MEG 2: THE TRENCH (2023); MOVIE REVIEW

Last year, around this time, I reviewed Baz Luhrmann's *Elvis* (2022). It was a cinematic masterpiece for the ages about the thrilling, and heartbreaking tragedy of the king of rock'n'roll, that told us something about America as a nation, and perhaps something about ourselves as individuals. I've seen just about every movie there is from *Casablanca* (1942) to *Oppenheimer* (2023). For my money, *Elvis* is the best movie ever made.

Glenn G. Hutchison - Simple, quiet man.

Our brother in the faith, Glenn Hutchison, passed away in May 2023. In his obituary, Glenn was described as a "simple, quiet man who enjoyed sunshine, old hymns, baseball hats, red pickup trucks and watching football on Sunday." To me, he will be remembered as a real Hero in the Faith.



I first got to know Glenn when he was teaching Confirmation Classes to my oldest son. I can still hear his words when teaching about the Confession. He was standing on top of a chair to get the kids' attention, and he said: "confession is in thought, word, and deed!." Another time, my son and I were shopping at South Park Mall, when we ran into Mr. Hutchison. Later, my son told me he was concerned Mr. Hutchison was going to ask him to recite the Lord's Prayer right then and there at the mall. Of course, Glenn would have never done anything like that. Glenn was a faithful servant at St. Paul, teaching Sunday School, Confirmation, and Vacation Bible School classes. He was passionate about sharing his faith with the younger generation.

After Betty, his wife, passed away, I noticed that Glenn's trousers were getting loose around his waist. Dave and I decided to have him over to dinner and feed him a calorie-rich meal. We decided the menu to be lasagna, salad, garlic bread and dessert. Glenn continued to amaze us that day because we discovered there was nothing wrong with his appetite. We had him as a guest for dinner a time or two after that, but not enough times, because I wish I had more memories to share about this remarkable man.

Here is one more story that I want to tell, but it is hard for me and makes me want to cry tears of joy and sorrow. A few weeks ago, the church was notified that Glenn named St. Paul Lutheran Church as the beneficiary of an insurance annuity that he held. That dear man loved his church, and he believed in continuing to support his church even in his death.

It is because of these things, i.e., his enthusiasm for teaching children, enjoying a meal with friends, his fondness for red trucks, and sunshine, that I will always remember Mr. Glenn G. Hutchison, as a hero in the faith.

The Church Council has directed the funds to be placed in a council directed account until it can be decided the best way to use the money. We wish to honor this man's legacy in the best way possible.

In July you will remember that we reported that in the last year we have had three locations where the copper water pipes in the building leak due to corrosion "eating" through the pipes. Investigation is complete and the specifications of the equipment suggested by Stack Heating and Cooling

have been verified so that a water filter and softener system will be installed to protect the water lines and the hot water heating lines from further damage. The proposal not only removes the problem minerals from the city water and boilers, but adds a tankless water heater to the kitchen to supply hot water specifically for the dishwasher. This will allow the dishwasher to use water much hotter for sterilization than allowed in the other sinks and facilities in the building. Council has formulated a financial plan to fund this project, and scheduling of the installation is in process.

The proposal that St. Paul received from the Solo Squares dancers offering to contribute to the expense of adding air conditioning to the Fellowship Hall is not quite "fine tuned" yet. A quotation to install a system that will blend perfectly with the interior of the Fellowship Hall has been received. The quoted cost does not include the installation of the wiring required to power the air conditioner because the cost of installing power lines around to the back of the building and then coming through the building to get to the air conditioners in Fellowship Hall is very expensive. Jim J. has proposed an alternative way this could be done, and the proposal has been conceptually approved by the Berea Fire Department. Cleveland Electric Illuminating has verified that the existing power transformers on the utility pole have the capability to power the proposed Fellowship Hall air conditioning equipment. The City of Berea Building Department Electrical Inspector now needs to approve the concept and provide specific construction criteria that must be followed to be approved. Once the proposal is detailed, the cost for providing the electrical power can be added to the equipment cost, and the funding total for the complete project can be considered.

We have received several compliments on how attractive the flowers and shrubs are on the West side of the Sanctuary facing Eastland Road, the courtyard, and the new flower bed around the electric sign on Bagley Rd. The flower beds are the creation of our dedicated lawn mower Jon Williams. He has had assistance from Linda Jungeberg, Amy Hofmann, Mike King, and flowers from Trish Jacobs and Corrine Bozin-Grizzell, so please let them know if you enjoy their creativity.

If the weather and schedules ever cooperate, we still plan to make repairs to the parking lot before winter so that we minimize the damage during the cold season before we can do some long term repairs next year.

The usual monthly reminder: When the major repairs and replacement of parts of St. Paul was built into the budget almost nine years ago now, the congregation was advised that a 7% increase in giving would be able to support that plan. The congregation has been faithful to their unanimous approval and allowed St. Paul to make several improvements that have reduced the upkeep and operating expenses for the congregation. In last

November's congregational meeting, the financial report showed that the level of giving has decreased about 5% in the last year, making it difficult if not impossible to continue with the annual repairs in the future years. Please prayerfully consider what you may be able to do to help offset this decrease so that we can continue to make the necessary repairs and replacements before they become more costly emergency situations.

Income and Expenses Summary Notes:

The YTD period ending July 31, 2023 has an operating deficit of \$32,372, \$19,866 more than July 2022's deficit. Congregational Contributions through July 2023 are \$12,189 less than contributions received through July 2022. Total Income is \$4,289 more than at July 31, 2022. Congregational Contributions are under budget by \$9,725 and Total Income is over budget by \$6,731 as of July 31, 2023. This increase in Total Income was the result of \$15,000 rent paid by Early Education Center (EEC) to the Church.

Note: Other Income includes periodic gifts made by the Thrivent Choice Donation program, clothing recycling program, and other miscellaneous

unrestricted income.

Expenses

Total expenses are under budget by \$7,763 as of July 31, 2023. Total expenses YTD are \$24,156 more than total expenses as of July 2022.

Note: Benevolence payments are percentages of contributions. Therefore, when contributions are higher, benevolence payments are higher.

Note on Budget Expenses: Total annual expense budget is \$368,611 or \$30,717 per month. In order to avoid the estimated \$80,496 annual deficit, revenue should equal the annual expense budget. As of July 31, 2023, we have a \$39,581 shortfall (\$215,019-\$175,438) of income to budget expenses.

MESSAGE FROM THE TREASURER:

HOW DOES GOD RESPOND TO YOUR GENEROSITY?

Greetings, I want to share a recent article by Rick Warren, which appeared in a Clint Hurdle, Daily Devotional, August 18, 2023, which was timely for **our** church:

"I heard a story about a man who took his son to McDonald's and bought him super-size French fries. On the way home, he reached over and took one little French fry and ate it. His son got upset and said, "Dad, you can't have that. These are my fries!" The dad immediately had three thoughts:

"First, my child has forgotten that I am the source of all fries. I took him to McDonald's, I paid for the order, I gave them to him, and I'm driving him back home. The only reason he got any fries was because of me, the Great Fry Giver!

"Second, my child doesn't realize I could take the fries away in a second if I wanted to. Or I could buy him an entire truckload of fries if I wanted to, because I have the power to do either.

"Third, I didn't need his fries. I could easily get my own. I could buy myself a hundred cartons of them if I wanted to. I just wanted him to learn to be unselfish." Those three lessons are the same ones God wants you to learn so that you can be generous with other people. First, God wants you to remember that he is the source of everything you've got. You would have nothing—you wouldn't even be alive!—if it weren't for God. Second, God could take it all away from you in an instant, or he could double it, because he's got the power. Third, God doesn't need your money. He just wants you to learn to be unselfish and develop your faith.

What happens when you start becoming a more generous person? "God is able to make it up to you by giving you everything you need and more so that there will not only be enough for your own needs but plenty left over to give joyfully to others" (2 Corinthians 9:8 TLB).

If you will practice generosity, God will give you everything you need plus more so you'll have enough to share with other people. He's looking for a channel like a straw, and when he finds it—someone who's willing to say, "God, use me to be a blessing to other people"—he just starts pouring blessing straight through it.

If you will learn to be generous, God will bless you more than you can imagine!"

USING AN INDIVIDUAL RETIREMENT ACCOUNT (IRA) FOR DONATIONS TO THE CHURCH

Did you know that if you are age 70 ½ or older that you can make a direct transfer from your Individual Retirement Account (IRA) to your church which satisfies your Mandatory Retirement Distribution (MRD) and **NOT PAY ANY INCOME TAX ON THE DISTRIBUTION!** That's right - NO INCOME TAX ON THE DISTRIBUTION and it qualifies towards any Mandatory Retirement Distribution (MRD). The limit that can be gifted is \$100,000.00 without it being counted as a taxable distribution. The distribution also is not included in the taxpayer's adjusted gross income (AGI) for determining premium increases for Medicare. However, this tax break means the donor cannot claim the donation as a deduction on Schedule A of their tax return. To take advantage of an IRA contribution to the church, the transfer must take place before the end of the year. If you are interested in making a contribution from your IRA please contact the church office and Dennis Mille will contact you to provide further information on making the transfer.

In addition to current contributions from an IRA, you may also want to consider designating St. Paul Evangelical Lutheran Church of Berea as a beneficiary of the IRA. A church receiving IRA distributions as a beneficiary does not pay any income tax.

Thank you for considering these methods of helping your church financially.

APPRECIATE YOUR BLESSINGS WITH APPRECIATED STOCK

Did you know that you can donate appreciated stock to the church? So long as you have owned the stock for more than one year (long term) then a donation of the stock avoids you paying income tax on any gain. You also receive a charitable contribution equal to the average of the high and low price of the stock on the date of your gift. The only limitation is that the value of the gift cannot exceed 30% of your adjusted gross income. You are also required to file IRS Form 8283 (Noncash Charitable Contributions) if you intend to itemize your charitable deductions for income tax purposes. Please contact the church office if you are interested in making a stock gift and Diane Jones, the Bookkeeper for St. Paul, will provide you with the necessary information to provide your financial institution to transfer the stock to the church. In addition, we can also accept stock certificates. Thank you for considering a stock gift to benefit the ministry and services of your church.
