HAVE A CELEBRATION COMING IN JANUARY?

The word Advent comes from the Latin, *adventus*, and means "coming." In the church, Advent refers to the coming of our Lord. Generally, we recognize three aspects of this coming.

Perhaps, the most obvious is our Lord's coming in his incarnation. There can be no doubt that Advent is, in part, a preparation for the celebration of Christmas. But it is also a time for reflection on the entire life and ministry of Jesus, from the manger in Bethlehem to the Cross on Calvary.

Advent also focuses on the coming of our Lord in the final judgment. This theme is conveyed most profoundly in readings often used in churches at this time such as Matthew 24:37-44, Mark 13:33-37, and Luke 21:25-37. The emphasis is not on fearful expectation, but on joyous anticipation. Yet, this anticipation can only be realized if one is properly prepared, which brings us to the third focus of Advent.

Most importantly, Advent focuses on the coming of our Lord in the Gospel proclaimed and administered in our midst. It is our Lord's coming to us in baptism, preaching, the holy supper, and in the way of Jesus practiced by his faithful followers that reveals the purpose of his coming in his incarnation. It is this same sacramental coming that prepares us to face the final judgment. Clothed in the white robes of righteousness, we watch and wait for the coming of our Lord in glory to judge both the living and the dead, confident that our sins have been forgiven and that our life is hid in Christ who has conquered all judgment.

Advent is a time of penitence, not unlike Lent. This is a season of fasting and preparation for the eschatological coming of our Lord. However, Advent is not a season of sorrow, but one of holy joy and anticipation. We prepare to meet our Lord at the final judgment throne of God by breaking the bread of the incarnation and taking hold of the cup of salvation. Fear is replaced with peace, and dread with hope.

The consumer culture has long used Advent as a marketing build up to a commercial holiday. And that's a lot of fun. But in the Church, it might be helpful if we make a conscious effort to also consider some of the more ancient themes of Advent. Particularly, our Lord's coming among us, first in his incarnation, at the last in his final judgment, and in between here among us as we share in his word, sacrament, and way of life.

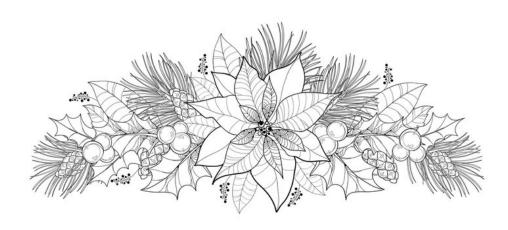

PROPERTY COMMITTEE

Last month Stack Heating & Cooling did a great job by doing both the routine maintenance on the boilers and installation of the water filtration system in one day. This allowed us to fire up the boilers and provide heat to our building the day before the cold arrived. In November Stack also installed the tankless hot water system to supply the dishwasher with water at 180 degrees F(the temperature required for disinfecting). Stack Heating & Cooling and Property formulated a plan that allowed preparations to be made and enabled the hot water system to be installed and operational in one day.

The proposal that St. Paul's received from the Solo Squares dancers offering to contribute to the expense of adding air conditioning to the Fellowship Hall is not quite "fine tuned" yet. A quotation to install a system that will blend perfectly with the interior of the Fellowship Hall has been received. The quoted cost does not include the installation of the wiring required to power the air conditioner because the cost of installing power lines around to the back of the building and then coming through the building to get to the Air Conditioner in Fellowship Hall is very expensive. Jim J. has proposed an alternative way this could be done, and the proposal has been conceptually approved by the Berea Fire Department, the Cleveland Electric Illuminating Co., and now the City of Berea Building Department Electrical Inspector has also approved the concept. Bids for the electrical supply are being obtained so the total cost of the potential project will be known and can be considered.

The Surface Engineering Paving Co. took advantage of a few hours of sun and made the patching repairs to the parking lot. These repairs should prevent further major damage to the parking lot during the coming winter season. We will evaluate some long term repairs next spring. Thanks to Steve Belle, the owner of Surface Engineering, for his efforts to be able to schedule the repairs without any interruption in the use of our building. Steve has also provided us with estimates for the repair of the various degrees of damage that our lot may incur during the winter months. As next spring approaches we will be able to visually inspect the parking lot surface and know what repairs and costs may be required next year.

The usual monthly reminder: When the major repairs and replacement of parts of St. Paul's was built into the budget almost ten years ago now, the congregation was advised that a 7% increase in giving would be able to support that plan. The congregation has been faithful to their unanimous approval and allowed St. Paul's to make several improvements that have reduced the upkeep and operating expenses for the congregation. In last November's congregational meeting, the financial report showed that the level of giving has decreased about 5% in the last year, making it difficult if not impossible to continue with the annual repairs in the future years. Please prayerfully consider what you may be able to do to help offset this decrease so that we can continue to make the necessary repairs and replacements before they become more costly emergency situations.

Exciting News: Growing in Faith is Coming!

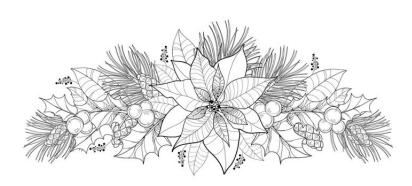
The Diakonia Program In the letter to the Ephesians we read: "I pray that, according to the riches of God's glory, you may be strengthened in your inner being

As we head into the Christmas season, my prayer is that 2024 brings more youth and young families to St Paul so that we can continue to grow and share the Love of Christ.

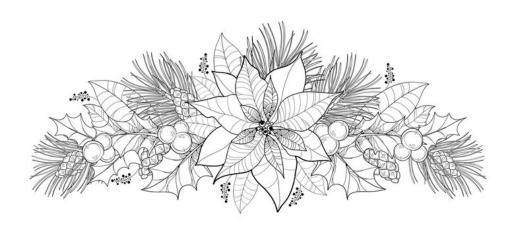

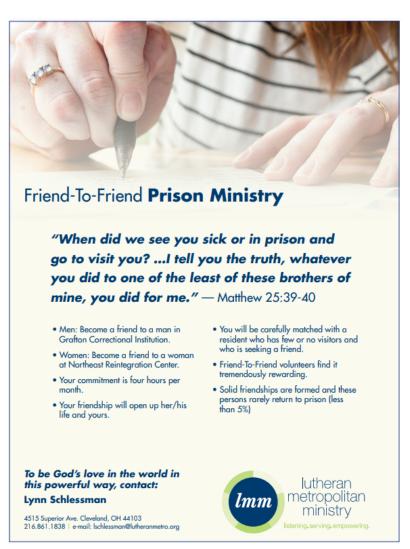


LUTHERAN METRO MINISTRIES (LMM) FRIEND TO FRIEND PROGRAM – PRISON MINISTRY

ABOUT ST. PAULY TEXTILE INC.

St. Pauly Textile Inc. is a Western NY based, family owned for-profit company and an A+ member of the Better Business Bureau. Our goal is to get USEABLE clothing to people who can use it, here in the U.S. and in developing countries, while having a meaningful impact in our local communities.



What to Drop-off:

Used Clothing, shoes, sneakers, belts, purses, linens, pillowcases, blankets, curtains, and stuffed animals.

What Not to Drop-off:

Furniture, electronics, household items, books, toys, garbage, pillows, rags, and fabric scraps.

How this works:

Community members drop off clothing at a clothing shed located at a community organization.

We (St. Pauly Textile, Inc.) purchase the clothing from the local community organization. The community organization uses the money that it receives from us in order to support its mission or complete important community projects. We sell and distribute the clothing that we purchase all over the US and World to organizations such as foreign governments, relief organizations, the U.N., private companies and the U.S. government.

This is the most cost effective way for these organizations around the globe to get large quantities of clothing for people in communities that they represent. All clothing is sold for pennies on the pound by St. Pauly Textile, Inc., in large quantities at a time.

Why people choose to drop off clothing at a clothing shed:

- 1) Our sheds are well-built and very attractive.
- **2)** Community members know this project is sponsored directly by the organization that hosts the shed...a local, community oriented non-profit.
- **3)** We guarantee that the sheds remain clean and attractive. Every week we monitor and empty the sheds. Year round our service team is available to perform maintenance on the sheds.

Why St. Pauly Textile Inc. collects clothing:

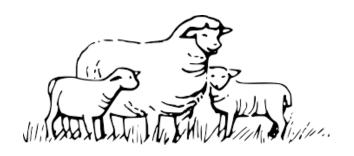
- **1)** According to the EPA, 85% of clothing in the U.S. is thrown away. This means that only about 15% of clothing that could potentially be re-used is collected using existing methods.
- 2) There is an enormous global need for used clothing. We are able to distribute clothing to organizations and people all over the world who could use it. All of the clothing and textiles that we collect is used by someone somewhere.

Why local community organizations choose to host a clothing shed:

- **1)** This project is a service to communities. This builds a unique connection between community members and the organizations that host our sheds.
- **2)** Clothing dropped off at a shed is distributed to people all over the world who could use it.
- **3)** We are able to provide anywhere from \$50 \$200 on average per month to local organizations that host our clothing sheds.
- **4)** We can give clothing locally if there is a need.

Organizations that host our sheds are free to use clothing from the shed for rummage sales, clothing give-aways, and any other circumstances where it is needed.

THE SECOND MILE OUTREACH (FORMERLY CHURCH STREET MINISTRIES)



OUR MISSION

"Second Mile Outreach is a non-profit organization providing food assistance, clothing, household goods and furniture for people in crisis and veterans in transition throughout the greater Cleveland community"

Church Street Ministries evolved into the Second Mile Shop, which features used furniture, clothing, accessories and a food pantry.

The Second Mile Shop is stocked with donated furniture, clothing, books, artwork and tchotchkes. Clients include the general public and people who need a helping hand.

The pantry buys food from the Cleveland Food Bank. In 2020, the pantry served 235,500 meals to 19,625 people.

Second Mile Outreach serves clients from throughout Cuyahoga County.

The Second Mile Outreach Pantry is open from noon to 2 p.m. Mondays, Wednesdays and Fridays. The thrift store is open from 9am to 5pm Thursdays and Saturdays.

Income and Expenses Summary Notes:

Income

The YTD period ending October 31, 2023 has an operating surplus of \$24,369. Of the \$80,344.04 received from Glenn Hutchison Annuity, Council designated \$52,344.04 to Misc Income reported as Other Income above (the annuity balance was directed by Council \$18,000 to Property Needs and \$10,000 to Living Endowment). Congregational Contributions through October 2023 are \$2,324 more than contributions received through October 2022. Total Income is \$74,509 more than at October 31, 2022. Congregational Contributions are over budget by \$686 and Total Income is over budget by \$54,773 as of October 2023. This increase in Total Inome was the result of \$15,000 rent paid by Early Education Center (EEC) to the Church and \$52,344 allocated to Other Income from the Hutchison Annuity.

Note: Other Income includes periodic gifts made by the Thrivent Choice Donation program, clothing recycling program, cash back credit card rewards and other miscellaneous unrestricted income. This includes \$52,344 from the Hutchison annuity gift.

Expenses

Total expenses are under budget by \$19,191 as of October 31, 2023. Total expenses YTD are \$29,955 more than total expenses as of September 2022

Note: Benevolence payments are percentages of contributions. Therefore, when contributions are higher, benevolence payments are higher.

Note on Budget Expenses: Total annual expense budget is \$368,611 or \$30,717 per month. In order to avoid the estimated \$80,496 annual deficit, revenue should equal the annual expense budget. As of Oct 2023, we have a \$6,099 gain . (\$313,269-307,170) of total income to budget expenses.

Balance Sheet Summary Notes:

Dedicated Funds include contributions designated for specific Council-approved categories (i.e. Memorials/Honorariums, Habitat for Humanity, Sheep and Goats contributions, Youth Trips/Projects, Music Ministry, Youth Ministry, and others). These funds are tracked separately and the contributions and/or expenses are not reflected in the Operating Income and Expenses Summary. A complete listing of the current Dedicated Funds can be found on the full balance sheet.

The Market Value of Invested Funds increased .12% in the month of October.



MESSAGE FROM THE TREASURER:

Greetings. Thank you to those who have taken the steps to increase their giving to help us meet the Congregation approved 2023 budget of \$368,611. Please continue to consider increasing your contribution for the remainder of the year if you can afford to do so. As you can see from the Financial Report we have a small operating gain of \$24,369 to actual

expenses. This was the result of the \$80,344 received from the Glenn Hutchison Annuity and Council designating \$52,344 to Miscellaneous Income. Please continue to prayerfully consider the blessings you have received and the gratitude gift you are able to donate to your church.

Did you know that asking a family member, neighbor or friend to attend our church services is a form of discipleship and similar to financial support expressing gratitude for the blessings you have received. USING AN INDIVIDUAL RETIREMENT ACCOUNT (IRA) FOR DONATIONS TO THE CHURCH

Did you know that if you are age 70 ½ or older that you can make a direct transfer from your Individual Retirement Account (IRA) to your church which satisfies your Mandatory Retirement Distribution (MRD) and **NOT PAY ANY INCOME TAX ON THE DISTRIBUTION!** That's right - NO INCOME TAX ON THE DISTRIBUTION and it qualifies towards any Mandatory Retirement Distribution (MRD). The limit that can be gifted is \$100,000.00 without it being counted as a taxable distribution. The distribution also is not included in the taxpayer's adjusted gross income (AGI) for determining premium increases for Medicare. However, this tax break means the donor cannot claim the donation as a deduction on Schedule A of their tax return. To take advantage of an IRA contribution to the church, the transfer must take place before the end of the year. If you are interested in making a contribution from your IRA please contact the church office and Dennis Mille will contact you to provide further information on making the transfer.

In addition to current contributions from an IRA, you may also want to consider designating St. Paul Evangelical Lutheran Church of Berea as a beneficiary of the IRA. A church receiving IRA distributions as a beneficiary does not pay any income tax.

Thank you for considering these methods of helping your church financially.

APPRECIATE YOUR BLESSINGS WITH APPRECIATED STOCK

Did you know that you can donate appreciated stock to the church? So long as you have owned the stock for more than one year (long term) then a donation of the stock avoids you paying income tax on any gain. You also receive a charitable contribution equal to the average of the high and low price of the stock on the date of your gift. The only limitation is that the value of the gift cannot exceed 30% of your adjusted gross income. You are also required to file IRS Form 8283 (Noncash Charitable Contributions) if you intend to itemize your charitable deductions for income tax purposes. Please contact the church office if you are interested in making a stock gift and Diane Jones, the Bookkeeper for St. Paul, will provide you with the necessary information to provide your financial institution to transfer the stock to the church. In addition, we can also accept stock certificates. Thank you for considering a stock gift to benefit the ministry and services of your church.

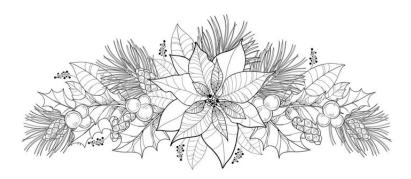

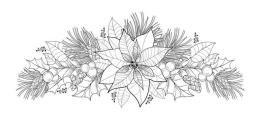
