## SUNDAY MORNING WEDDINGS

It's July, and wedding season is in full swing. Summer weddings are all the rage. And I don't think there's a more popular day to get married than a Saturday in June, July, or August. Fourth, Sunday afternoon wedding receptions can rock just as hard as evening ones. In fact, they can be better because no one is tired. There's plenty of time for pictures. No one is rushing to get home before they turn into a pumpkin. And when the formal reception is over, there's still time for a pretty killer after-party for close friends and family. Or, you can use that time to reflect on one of the most special days of your life. Plus, it's often a lot less expensive to rent a hall for a Sunday afternoon than a Saturday night.

Finally, if you're honeymooning right after the wedding, plane tickets are cheaper when you fly out on a Monday morning than a weekend. Hotels are cheaper at the beginning of the week, too.

## COUNCIL CORNER

The local church is “Supernaturally Empowered, Brilliantly Designed, and Strategically Positioned.” – Tom Nelson, President of Made to Flourish and Senior Pastor of Christ Community Church, Kansas City.

In the book “Whatever You Do for An Integrated Life” published by Made to Flourish, Pastor Tom Nelson makes a case for the importance of the local church as being “God’s plan A for redeeming a broken world”.

Let’s consider God’s plan A, in the context of St. Paul Lutheran Church.

This means that we should give thanks for our rich history, celebrate our current state as a Priesthood of Believers, and look with hope for the future livelihood of our beloved St. Paul church. God’s house is like the family. It is a home and place to practice being loved and loving others. Our brick-and-mortar home is not only a place of Worship, but it is used by Guide Dogs for the Blind, people who enjoy Square Dancing, baby showers, and much more.

St. Paul Church is strategically positioned. Whoever it was that decided to build our church on the corner of Bagley and Eastland Roads was a true visionary. We are so very fortunate to be so visible and accessible with a prominent location in the City of Berea. I know that sometimes the local church can be disappointing, frustrating, or difficult to navigate. But the Pastor, Church Council, and supporting committees such as Worship, Property and Finance are united to bring the highest and best ministry for the sake of Jesus, the community, and all creation.

God’s plan A allows the local church and the people who attend it a chance to learn about and participate in enriching lives, meeting needs, and a concerted effort for renewal of all things for the good of humankind and creation. ## PROPERTY COMMITTEE

Leveling of the uneven sidewalk pavement by doors #1 and #2 is completed. Next we hope to clean out the cuts between the slabs of concrete with a power washer and caulk the access between the slabs to prevent the rain and salt water from getting below the pavement and then freezing and raising the slabs back up again.

The Annual Key Bank Neighbors Make a Difference Day took place on June 13<sup>th</sup>. Volunteers from Key Bank were privileged to witness Divine intervention and then assist us the afternoon of that day to spread mulch on the flower beds and courtyard. As the last volunteers arrived the rain ceased and the sun shone brightly. We were able to spread mulch to all areas and finish applying all 17 cubic yards of mulch in a record time of only one and one half hours. Our deepest thanks to the volunteers from Key Bank and the members of St. Paul for a remarkable effort and success.

In the last nine months we have had three locations where the copper water pipes in the building leak due to corrosion “eating” through the pipes. We have had water samples of both the domestic water and the boiler water system tested, and found that the city water supplied, although safe by EPA specifications, is very high in mineral content. In order to stop the corrosion, we have solicited the assistance of Stack Heating and Cooling because the heating system is at risk as well. We have received a proposal from Stack to install a filter and water softener system. The proposal not only removes the problem minerals from the city water, but adds a tankless water heater to the kitchen to supply hot water specifically for the dishwasher. This will allow the dishwasher to use water much hotter for sterilization than allowed in the other sinks and facilities in the building. Council is formulating a financial plan to fund this project, while the technical details of what routine service will need to be performed and the financial impact that may have as well.

St. Paul has received a proposal from the Solo Squares dancers offering to contribute to the expense of adding air conditioning to the Fellowship Hall. A quotation to install a system that will blend perfectly with the interior of the Fellowship Hall has been received. The quoted cost does not include the installation of the wiring required to power the air conditioner because there are optional ways this could be done, depending upon the Berea building inspectors, the Berea Fire Department, and Cleveland Electric Illuminating see our particular building. Meetings with two of the three organizations have been held and if a favorable method is approved, the installation cost of the power wiring will be kept down. Once this cost to supply power is determined, the entire cost of the system installation will be known, and proposals for the financial sharing of costs can be presented.

The usual monthly reminder: When the major repairs and replacement of parts of St. Paul was built into the budget almost nine years ago now, the congregation was advised that a 7% increase in giving would be able to support that plan. The congregation has been faithful to their unanimous approval and allowed St. Paul to make several improvements that have reduced the upkeep and operating expenses for the congregation. In last November's congregational meeting, the financial report showed that the level of giving has decreased about 5% in the last year, making it difficult if not impossible to continue with the annual repairs in the future years. Please prayerfully consider what you may be able to do to help offset this decrease so that we can continue to make the necessary repairs and replacements before they become a more costly emergency situation.

## Income and Expenses Summary Notes:

### Income

The YTD period ending May 31, 2023 has an operating deficit of \$10,145.54, \$3,791 more than May 2022's deficit. Congregational Contributions through May 2023 are \$10,580 less than contributions received through May 2022. Total Income is \$4,502 more than at May 31, 2022. Congregational Contributions are under budget by \$1,798 and Total Income is over budget by \$14,446 as of May 31, 2023. This increase in Total Income was the result of \$15,000 rent paid by Early Education Center (EEC) to the Church.

**Note:** Other Income includes periodic gifts made by the Thrivent Choice Donation program, clothing recycling program, and other miscellaneous unrestricted income.

### Expenses

Total expenses are under budget by \$10,098 as of May 31, 2023. Total expenses YTD are \$8,298 more than total expenses as of May 2022.

**Note:** Benevolence payments are percentages of contributions. Therefore, when contributions are higher, benevolence payments are higher.

**Note on Budget Expenses:** Total annual expense budget is \$368,611 or \$30,717 per month.

In order to avoid the estimated \$80,496 annual deficit, revenue should equal the annual expense budget. As of May 31, 2023, we have a \$19,092 shortfall (\$153,585 - \$134,493) of income to budget expenses.

## Balance Sheet Summary Notes:

**Dedicated Funds** include contributions designated for specific Council-approved categories (i.e. Memorials/Honorariums, Habitat for Humanity, Sheep and Goats contributions, Youth Trips/Projects, Music Ministry, Youth Ministry, and others). These funds are tracked separately and the contributions and/or expenses are not reflected in the Operating Income and Expenses Summary. A complete listing of the current Dedicated Funds can be found on the full balance sheet.

The Market Value of Invested Funds decreased 1.36% in the month of May.

Greetings, We offer and encourage electronic giving as a way to automate your regular weekly offering. Electronic giving offers convenience for individual congregation members and provides much-needed donation consistency for our congregation.

Direct debit giving is used to automatically transfer funds from your checking or savings account to the church's bank account.

Credit and debit card giving allows you to make offerings automatically on a pre-determined schedule using your credit or debit card. You can also designate the small processing fee that is paid by the church as an additional contribution.

Online giving allows you to go to [StPaulBerea.org](http://StPaulBerea.org) at any time to set up an automatic donation plan, change your donation plan, select monthly Sheep and Goats donation, make a one-time donation, or view your online donation history.
